To say the least, it's been a tumultuous week in both Israel and the U.S.

In this week's edition you'll start off with articles about the fight between the Chief Justice of Israel's Supreme Court, Miriam Naor, and Israel's Justice Minister, Ayelet Shaked. The dispute centers on procedures for appointing four new justices to Israel's Supreme Court next year; but actually the question is who controls the Supreme Court and its decisions. Naor is determined to hang onto the veto of new members of the court possessed by the justices since 2008. Shaked seeks to move the court toward the political right.

All of which may well affect our issues.

clashed last week over Shaked's support for legislation that would deprive the Supreme Court justices on the court of a veto over the appointment of new justices to the court. Shaked said she would support the bill if a consensus was not reached on new appointees.

Last week, Naor accused Shaked in a letter of "putting a gun on the table" over her support for the legislation at this time.

Shaked on Sunday released a list of the 28 candidates nominated to the Supreme Court whom the judicial selection committee will be considering to fill four vacancies on the high court next year. Naor as well as Justices Zvi Zylbertal, Salim Joubran, and Elyakim Rubinstein will be retiring next year. Zylbertal's term does expire until 2022, but he is understood to be ready to step down.

Naor wrote that as a result of Shaked's support for the bill, the justices on the committee would not engage in preliminary discussions on the nominees. On Sunday, however, the two met and agreed that the two sides would resume discussions behind the scenes. A source told Haaretz that the differences between the two are still wide, but Shaked told Naor that she would only support the legislation if Justice Zylbertal, who is expected to resign in April, leaves the court without a replacement.

## 'You have placed a gun on the table'

***High Court Chief Justice Miriam Naor sent a sharp letter Wednesday to Justice Minister Ayelet Shaked in the wake of the proposed law cancelling the need for a majority of 7 out of 9 members of the selection committee when selecting new judges.***

Naor wrote initially that despite the proposal being a private MK's proposal, since it has been publicized that Shaked supports the proposed law and she has not denied her support, she assumes that Shaked indeed stands behind the initiative.

"Submitting this proposal at the present juncture constitutes 'placing a gun on the table'. It means that if some members of the committee will not express their approval of certain candidates, and there will not be a special majority enabling their appointment, the constitutional 'rules of the game' will change so that they can be appointed by a regular majority of the selection committee," wrote Naor.

Naor added "I wish to emphasize that we do not intend to intervene in the Knesset's legislative procedures even when they constitute a change in the 'rules of the game' . We are also not involved in speculations about possible legislative processes or their propriety. However, it is clear that, just as the legislative authority acts as it sees fit, we too - the judges who are members of the judiciary selection committee - will each act as we see fit, all within the confines of the law."

בדו"ח שמפרסם מרכז ליב"ה, ואשר הוגש הבוקר לחברי ועדת הפנים אשר דנים הבוקר בסוגיית הכותל המערבי, מוצגים מקורות המימון של רבנים לזכויות אדם, המורכב ברובו מרבנים רפורמים. בישראל ישנן 54 קהילות רפורמיות ו-17 מהעומדים בראשן הם חברים ב'רבנים לזכויות אדם' או בעלי תפקידים בכירים בארגון.

הארגון, הפועל לסיוע לערבים ברחבי יהודה ושומרון ורצועת עזה, היווה חלק ממקורות דו"ח גולדסטון שתיאר את פעולות צה"ל ברצועת עזה כפשעי מלחמה.

הארגון אף פועל בקשר הדוק עם ארגון הקיצוני תעאיוש, אשר שנחשף בתחקיר "עד כאן", כי שני הארגונים פעלו לשכנוע פלסטינים להשתלט על אדמות מדינה ביהודה ושומרון.
